Librarians are concerned that they are unable to trace traffic from discovery to fulfillment. Example:IEDL data cannot be captured via OBI; unable to track access problems related to iframes etc.

How does Ex Libris plan to address these gaps? It makes our job tougher to justify resources when usage appears to be going down; we need to able to prove otherwise.

Analytics

Has there been any thought given to adding browse searching in Summon similar to an OPAC? There is a market for browse searching in Summon, especially for sites without an OPAC.

SOA customers rely on Summon exclusively for discovery and no longer maintain a legacy OPAC. This is particularly problematic when seeking a particular resource, but even a title phrase search in Summon pulls up more results than patrons expect.

Summon Over Alma

Can you explain your reasoning behind allowing resources to have only one content type definition?

Example: government documents can be journal articles, magazine articles, books, etc., but in Summon, if items have a content type of government document they can't be anything else.
